Minutes of Rossford City Council Organizational Meeting
Held December 2, 2019

SWEARING IN: Re-elected Mayor Mackinnon was sworn in by Perrysburg Municipal Court Judge Aram Ohanian. Mayor Mackinnon swore in reelected council members Larry Oberdorf and Greg Marquette.
